

Accounts Receivable Industry Report Q1 2020

A Quarterly Report for Benchmarking Accounts Receivable Performance.





Summary

This report is designed to help you benchmark the payment performance of your customers and partners against similar businesses in the same industry. It lists the details of 21 key sectors, made up of over 700 industries by SIC code. We have grouped this report into broad sectors based on 2 digits SIC code groupings to make it easier for you to identify the key sectors of interest to you.

This report shows the percentage of invoices paid on time or within terms, then up to 30 days late, up to 60 days late, up to 90 days late and beyond 90 days late. We have also included the average number of days beyond terms (DBT) for the sector and an indicator as to whether this is improving, stable or worsening.

While the report is not designed to be used as a stand-alone decision-making tool we recommend that you use the information in it to benchmark your own accounts receivable performance against industry averages to identify potential areas of improvement or update existing credit policies.

Methodology

This report is created by analysing trusted accounts receivable data from Creditsafe customers. In this report, we analysed almost 15 million invoices which were paid in Q1, 2018, 2019 & 2020 to identify trends and highlight the typical payment performance of companies within certain sectors.

Important note

In the light of the challenges posed to the economy by the ongoing Coronavirus pandemic we are aware that payment trends may well be changing significantly when compared to the situation earlier in the year. Therefore, we recommend that you use the information in this report to compare industry averages against your own data over the whole of Q1 2020.

We are carefully monitoring the situation on a daily basis with all our payment data suppliers and recognise that certain industries are being impacted significantly harder than others. A preliminary review of April's data is already showing a slowing down in the number of invoices being issued and an apparent extension or loosening of payment terms in many sectors. We will therefore be looking to issue regular updates including any relevant additional data as we see what effect the pandemic and lockdown have on behaviours in order to help you in continuing to make sound trade credit lending decisions during these challenging times.



Sector Overview

% of late payments

Across all 21 sectors, on average, 43% of all invoices paid in Q1 2020 were paid beyond agreed terms. Only 8 out of 21 sectors saw an improvement in late payments compared to the same period in 2019. Mining, Transport and Real estate companies were the biggest contributors of late payments compared to Q1 2019.

Days beyond agreed terms (DBT)

When looking at the average number of days beyond given terms (DBT), we can see that 11 of the 21 sectors showed signs of improvement; however, of those worsening, the DBT increased by an average of 4 days in Q1 2020 compared to the same period in 2019.

Agriculture, Forestry and Fishing

Companies within this sector grow crops, raise and fatten animals for food products, and grow and harvest timber. Crop producers grow grain, tobacco, vegetables, fruits and nuts.

This sector includes the sale of new and used cars and motor vehicles, wholesale of timber and building materials, food and beverage wholesale and all retail trade from stores and online.

This sector includes all types of transport companies, including; public transport, freight, rail, air and sea transport. It also includes removal services, warehouses and storage and postal and courier services.

Hospitality

Accommodation companies in this sector include; Hotels, holiday and caravan parks, youth hostels and B&B's. Food and beverage companies include; licenced and unlicensed restaurants, cafes, take-away food shops, event catering services, public houses, bars and licenced clubs.

This sector takes an average 29 days to pay its suppliers, with 70% of invoices being paid on time.

It also includes recruitment agencies, travel agencies, cleaning companies and general facilities management. Office administrative support companies include, call centres, exhibition and event halls, conference organisers, credit bureaus, collection agencies, packaging companies and other business support activities.
